Corrections to DOT Errors Received from VERTEK

Spelling Errors

We accept all spelling corrections which you noted on the six pages, except those noted below: (In some cases there may have been a typo during compilation of the list.)

<u>DOT</u>	<u>Error</u>	<u>Correction</u>
✓ 018.167-034	coutors	correct to "contours" not "contors"
✓ 020.131-010	activites	"activities" There is no such DOT Code. However, the occupation 820.131-010 has the "activites" error and does not appear on your list.
✓ 193.262-020	acknowledgement	"acknowledgment" There is no such DOT Code. However, the correction needs to be made to 193.262-030.
✓ 215.362-018	officers's	<i>rec 14a-b</i> "officers'" In addition, add an "s" to the next word in the sentence to make it "logs".
✓ 243.362-020	trnscribes	"transcribes" There is no such DOT Code. However, the correction needs to be made to 243.362-010.
✓ 315.313-010	requistion	"requisition" There is no such DOT Code. However, the correction needs to be made to 315.131-010.
✓ 525.685-014	stuffing stuffing	We stand by the phrase "sausage-stuffing stuffing machine".
✓ 603.280-034	annd	We found the error in 600.360-010 rather than in 603.280-034.
✓ 632.380-014	platesful	"platefuls" (according to pages 68-69 of 1984 U.S. Government Printing Office Style Manual - our style reference.
✓ 681.685-098	Lastex	Lastex-Thread Winder is an Undefined Related Title that has been in the DOT since the first edition. The occupation was not studied for the revised fourth edition. Based on new, (not-yet obtained) source material and current standards, the title, as currently spelled would probably not be included in future editions.

✓ 784.684-074 shellacks

According to our desk dictionaries, the spelling of "shellacks" and "shellacked" are correct as they are used in this definition.
